Wu esil rlewil Poq Marlin rech Montana Exploradora de Guatemala S.A., are' kya'wuul ri poq chu Goldcorp Inc de Vancouver, Canadá, kriqtjik chu qajb'al q'ij rech Paxil. 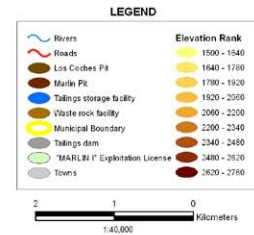
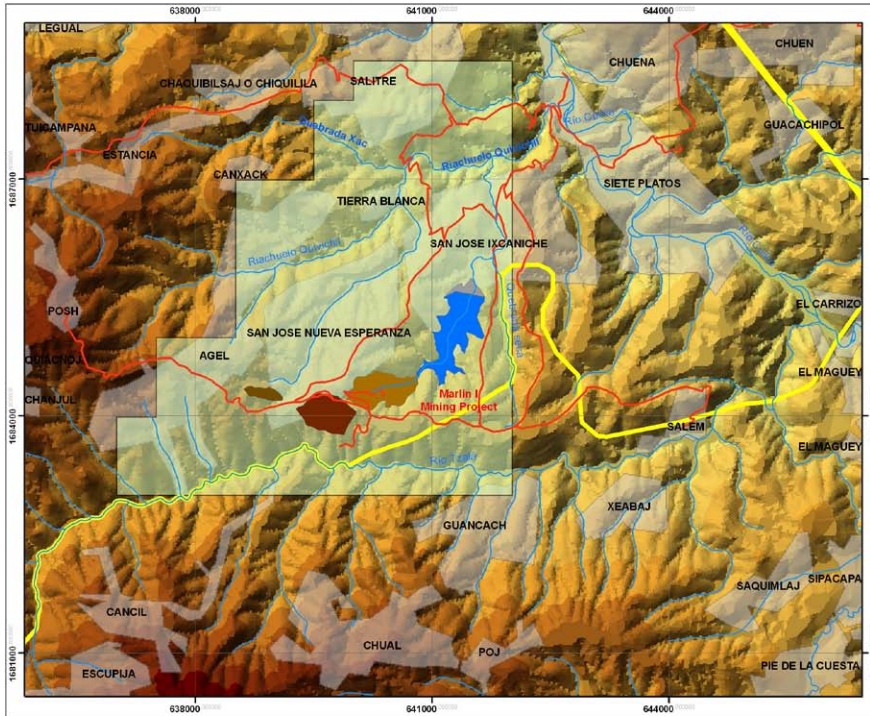
